

## HELPING WINGS

### **Disclaimer, Waiver and Licence**

Helping Wings is a Jersey registered charity which aims to share the excitement of flying in a light aircraft with those who would otherwise not have the opportunity to fly.

As with most charities, Helping Wings is staffed entirely by volunteers who give up their time and allow their light aircraft to be used free of charge and that is what makes our activity days so successful.

In return for enjoying a Helping Wings' activity day, we ask that each participant (if under under 16 years of age, their parent, guardian or caregiver) sign this disclaimer, waiver and licence form. This allows Helping Wings to make each activity day so memorable for everyone.

Participation on a Helping Wings activity day is unfortunately not permitted without this disclaimer, waiver and licence form, being signed.

### **Disclaimer**

Flying in light aircraft and participating in a Helping Wings' activity day carry risks which we cannot entirely eliminate. These include, but are not limited to, the risk of property theft, or damage, bodily injury, and/or death when walking to and from an aircraft, boarding and disembarking an aircraft, or in the unlikely event of an aircraft malfunction.

While taking part in the activity day or when flying in a light aircraft, Helping Wings requests that you:

- Act responsibly and sensibly at all times.
- Follow the safety warnings or instructions displayed or given to you by a Helping Wings pilot or an Airside Escort.
- Do not participate if you do not like loud noises, heights, suffer from air sickness or generally feel unwell.
- Do not participate if you are pregnant or under the influence of alcohol or non-prescription drugs.

Helping Wings is not qualified to express an opinion that you can safely participate in one of our activity days. If in doubt you must obtain advice from your doctor before doing so.

In the absence of any negligence or other breach of duty by us:

- (a) participation in the activity day is entirely voluntarily and entirely at your risk; and
- (b) Helping Wings is not responsible for any theft, damage, destruction or loss of your property or belongings while using our facilities or participating in our activity day.
